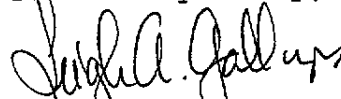

ARTICLES OF INCORPORATION
OF
DEFYING GRAVIOTY, INC.

ARTICLE I

The neme of the corporation is DEFYING GRAVITY, INC.

ARTICLE II

The location of its principal office in the State of Florida is 5461 S.E. 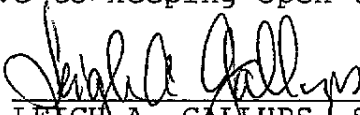

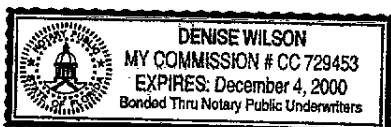
