

ARTICLES OF INCORPORATION

OF

MOP WASHER, Inc.

ARTICLE I - NAME

The name of this Corporation is **MOP WASHER, Inc.**

ARTICLE II - DURATION

This Corporation shall exist perpetually commencing on the date of the execution of these Articles.


