The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the Corporation shall be Promark Financial Services, Inc. The principal place of business shall be 5141 Monterey Lane, Delray Beach, Florida 33486.

ARTICLE II. NATURE OF BUSINESS
