ARTICLES OF AMENDMENT TO THE OF INCORPORATION OF

RITA POLIT & CO., INC.

Pursuant to the provisions of Section 67.1006 of the Florida General Corporation Act, the undersigned corporation adopts the following Articles of Amendments to its Articles of

- The current name of the corporation is RITA POLIT & CO, INC..
- The following amendments of the Articles of Incorporation were adopted by the shareholders (or board of directors if no shares have been issued) of the corporation on April 14, 1999, in the manner prescribed by the Florida General Corporation Act and the Professional Service Corporation Act:
