We, the undersigned incorporators, do hereby make, subscribe, acknowledge and file with the Secretary of State, State of Florida, these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ONE

The name of the corporation shall be:

TWO

The general nature of the business to be transacted by this corporation shall be as follows:

- A. To practice law.
- B. To purchase, lease and hold real and personal property and any and every interest therein and chooses in action secured thereby; to improve manage, operate, sell, mortgage, lease and otherwise dispose of any property; to loan money to take mortgages and assignments of mortgages upon such property and to transact all or any other business which may be necessary, incidental or proper to the exercise of any or all of the aforesaid purposes of the corporation.

To borrow money and contract debts when necessary for the transaction of its business or for the exercise of its corporate rights, privileges or franchises, of any other lawful purposes; to issue bonds, promissory notes, bills or exchange, debentures and other obligations and evidences of indebtedness, payable at a specified time or times secured by mortgage or otherwise.
- D. To guarantee, purchase, hold, sell, assign, transfer, mortgage, pledge or otherwise dispose of the shares of stock of, or any bonds secured or evidence of Indebtedness created by any other corporation or corporations and while owning said stock to exercise all rights, powers and privileges of ownership, including the right to vote thereon.

- H. The foregoing clauses shall be construed both as objects and powers; and it is hereby expressly provided that the foregoing enumeration of powers shall not

This corporation shall have a perpetual existence.


SIX


