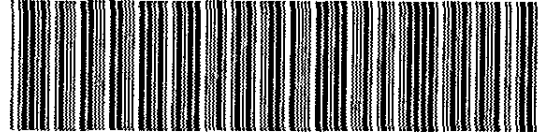

ARTICLE III

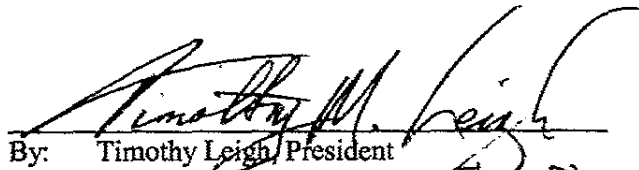
