Under Chapters 607 and 621 of the Florida Statutes:

The undersigned, being a natural person of at least 18 years of age and acting as the incorporator of the corporation being hereby formed under the Florida Corporations Statutes, certifies that:

First: The name of the corporation is MY LITTLE CLOSET, INC.

Second: The corporation's principal place of business shall be 4100 North 43rd Avenue, Hollywood, Florida 33021.

Third: The corporation is formed for the following purpose or purposes:

To engage in any lawful act or activity for which corporations may be organized under the Florida Statutes, provided that the corporation is not formed to engage in any act or activity requiring the consent or approval of any state official, department, board, agency or other body without such consent or approval first being obtained.
