# ARTICLES OF INCORPORATION

OF

SULTAN SIDDIQI, the undersigned, hereby associate, ATSUL CORPORATION, for the purpose of becoming a corporation for profit under the laws of the State of Florida, and do certify that ATSUL CORPORATION, has become such corporation under and pursuant to the following Articles of Incorporation.

#### ARTICLE I

The name of this corporation shall be: ATSUL CORPORATION and its principal place of business is: 3970 Circle Lake Drive, West Palm Beach, FL 33417.

# ARTICLE II

The general nature of the business to be transacted and carried on by this corporation and its object and purpose is: To transact any and all lawful business regardless of its nature or description.

## ARTICLE III

The maximum number of shares which this corporation shall be authorized to issue and have outstanding at one time shall be limited to One Hundred (100) shares of common stock, Ten Dollars (\$10.00) par value.

The consideration for the issuance of such shares of stock, or any part thereof, shall be money current of the United States of America, or property or services of value at least equivalent to the value of the stock to be issued, the same to be fixed and determined by the Board of Directors of this corporation at any meeting of the Board. Whenever any share or shares of stock are issued in consideration of payments to be made in property or in services, the fair and just value of the property to be transferred or the services to be performed or rendered as a consideration for the issuance of said stock, shall be fixed by the Board of Directors of this corporation at any regular meeting of the Board or at any special meeting for which the fixing of that value is one of the purposes for which the meeting is called. 
