ARTICLE I



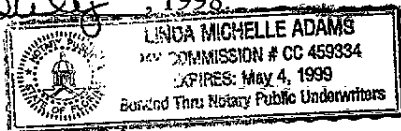


