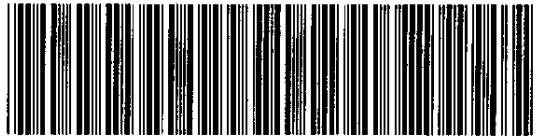



We have no knowledge of the means by which the "All Florida Firm" committed its fraud against the company, and are reporting this fraud immediately upon learning of it. We request that the records of the Department of State, Division of Corporations be amended to reflect the fact that the "All Florida Firm," its officers, agents, and employees, have never had any legal authority to serve as registered agent for B&S Utilities, Inc., in any matter or proceeding at any time.
