ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
PJLF ENTERPRISES, INC.

Document Number P98000067727

Pursuant to Section 607.1006 of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

1. The name of the corporation is PJLF ENTERPRISES, INC.
2. The following amendment to the Articles of Incorporation (amending Article 4) was adopted by unanimous written consent or vote of the shareholders and directors of the corporation on the 30th day of September, 2002 in the manner prescribed by the bylaws of the corporation and the Florida Business Corporation Act.

Article 4 is amended to read as follows:

"ARTICLE 4. Capital Stock

The Corporation is authorized to issue 1,000 shares of Common Stock, at par value of One (\$1.00) Dollar per share. 100 shares which have been issued and are currently outstanding as of the date of this amendment have full voting rights and shall be designated the "Voting Common Stock". The remaining 900 non-issued shares shall have no voting rights and shall be designated the "Non-Voting Common Stock". In no event shall this delineation and designation be regarded as creating a second class of stock for purposes of Section 1361(b)(1)(D) of the Internal Revenue Code or any related Section which could impact the classification of this Corporation as an S-Corporation for purposes of the Internal Revenue Code.
