ARTICLE I - NAME

The name of this corporation is EAST COAST PDR, INC.. The principal address of this corporation is 2341 N.W. 33RD STREET, FT. LAUDERDALE, FLORIDA 33309.

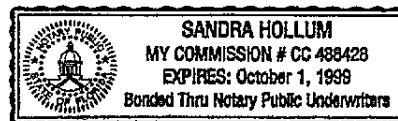
