ARTICLE I-NAME

The name of this corporation is
NORMA L. GREENWOOD, P. A.

ARTICLE II-DURATION

This corporation shall exist perpetually, commencing on the
first day of August, 1998.

ARTICLE III-PURPOSE

This corporation is organized for the purpose of transacting
any and all lawful business relating to that of a Real

ARTICLE IV-CAPITAL STOCK

The corporation shall indemnify any officer, director or stockholder, or any former officer, director or stockholder to the full extent permitted by law.


ARTICLE XI-AMENDMENTS
