

3. No shares of the corporation having been issued, the board of directors adopted this amendment by resolution on August 7, 1998.



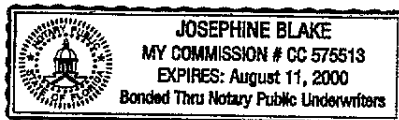




