# ARTICLES OF INCORPORATION

OF

## ARTICLE ONE

The name of this corporation is CROSS HAVEN FARMS, INC. and the mailing address of the corporation shall be 12600 Morgan Hill Road, Fort Myers, FL 33912.

## ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed.

## ARTICLE THREE

The duration of the corporation is perpetual.

## ARTICLE FOUR

The general purposes for which the corporation is organized are:

- 1. To engage in the business of equine activities including boarding of horses.
- 2. To transact any other lawful business for which corporation may be incorporated under the Florida General Corporation Act.
