ARTICLES OF INCORPORATION

A FLORIDA CORPORATION

Pursuant to the provisions and requirements of Chapters 607, Florida Statutes, and for the purpose of forming a corporation in accordance with the "Florida Business Corporation Act", the following Articles of Incorporation are hereby adopted and set forth:

ARTICLE I

The name of the corporation is: Ka-Ke Creations, Inc.

ARTICLE II

The principal place of business of the corporation shall be 316 Dr. Mary McLeod Bethune Blvd., Daytona Beach, FL, 32114.

ARTICLE III
