Pursuant to the provisions and requirements of Chapters 607, Florida Statutes, and for the purpose of forming a corporation in accordance with the "Florida Business Corporation Act", the following Articles of Incorporation are hereby adopted and set forth:

ARTICLE I

The name of the corporation is: **Ka-Ke Creations, Inc.**

ARTICLE II

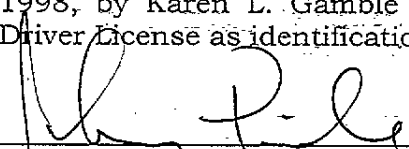
