ARTICLE I - NAME

The name of this corporation is SIERRALTA COMMUNICATIONS, INC.

ARTICLE II - DURATION

This corporation is to have perpetual existence commencing August 3, 1998.

ARTICLE III - PURPOSE

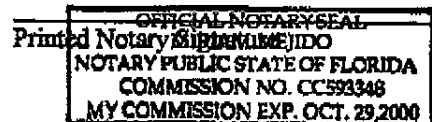
