ARTICLES OF INCORPORATION OF SPORTING PLUS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME / PRINCIPAL OFFICE
