Enclosed please find a copy of your letter dated July 17, 2000 regarding Ardent Technology Solutions Inc. as well as our check for \$300.00 along with our application for reinstatement dated and signed 5-23-00.

In your letter you indicate in order to process our application for reinstatement you need an explanation as to why we are requesting the fees be waived from Ardent Technology for late filing. It is a result our registered agent not advising the state of Florida to transfer the mailing of all document to our corporate office in Illinois.

Unfortunately, the original application was sent to our location in Fort Meyers, Florida. The mail system of the U.S. Post Office in Florida has discontinued forwarding the mail, and therefore the application was never forwarded to Illinois for our proper completion and submission on a timely basis.
