ARTICLE NAME

The name of this corporation is J.M.S. & Associates, Inc.

ARTICLE II

PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is: 2411 S.W. 7th Avenue, Miami, Florida 33129.

ARTICLE III

NATURE OF BUSINESS

This Corporation is being formed for the following purposes:

- (a) To engage in any and all lawful business or activity permitted under the laws of the United States and the State of Florida.
