ARTICLES OF INCORPORATION OF

ARTICLE I - Name

The name of this corporation is SAVVINIDIS & ASSOCIATES TRAVEL CONSULTANTS, INC.

ARTICLE II - Street Address and Mailing Address


ARTICLE IX - Indemnification

ARTICLE X - Amendment


