Dear Ms. Peterson:

I am taking the liberty of enclosing a copy of my previous letters dated June 11, 2003 and June 21, 2003 addressed to the Division of Corporations, P.O. Box 1500 in Tallahassee, Florida. I am also enclosing the original 2003 UBR form, which I just received, requesting a filing fee of \$550.

As I explained to you by telephone this afternoon, I previously sent the Division of Corporations our completed report as well as our check in the sum of \$150.00, along with a letter explaining why our filing was late. My explanation is given in detail in my first letter dated June 11, 2003 and is given again, as follows:

In early late September, 2002 my wife was diagnosed with breast cancer for the second time. She underwent a total mastectomy at the Coral Springs Medical Center, Coral Springs, Florida on October 16, 2002. This situation is an ongoing problem and she is constantly being monitored by various specialists.

In October, 2002 our daughter was diagnosed with an almost complete collapse of her spinal cord. On November 5, 2002 she underwent a spinal fusion operation at Joe DiMaggio Hospital in Hollywood, Florida. Our daughter was out of school for almost 12 weeks, being turned over to "Homebound" studies through the Broward School District. She finally returned to school on a limited basis and just completed her freshman year at Stoneman Douglas High School.

In April of this year, my wife slipped and severely broke her left elbow. She was operated on April 28, 2003 again at the Coral Springs Medical Center. Her surgery was extremely difficult and lasted 4 hours. Her elbow was almost completely reconstructed during this 4 hour operation, which involved the work of 2 surgeons. She is actively involved in physical therapy beginning this week.
