

#### ARTICLE I NAME

The name of this corporation is CAMPBELL YACHT CHARTERS, INC.

#### ARTICLE II DURATION

The corporation shall have a perpetual existence.

#### <u>ARTICLE III</u> PURPOSE

The general nature of the business to be transacted is all lawful business, including the authority:
