The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

NAME

The name of the corporation is: J&L PUBLISHERS, INC.

ARTICLE II

LOCATION

The location of its principal place of business is 312 Payne Drive, Miami Springs, Florida.

ARTICLE III

INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 312 Payne Drive, Miami Springs, Florida, 33166, and the initial registered agent of this corporation at the address is JUANITA E MIQUEL GARCIA.

ARTICLE IV

DURATION

This corporation shall have perpetual existence commencing on the date of filing of these Articles with the State of Florida, Department of State.

ARTICLE V

PURPOSE

This corporation is organized for profit and its corporate purpose is to create and publish newsletters and other works for information to the public.

Said corporation shall further have powers to engage in any and all things in which a corporation organized under the laws of the State of Florida may engage.

The above restriction on issue and transfer may be amended from time to time as deemed in the corporation's best interests, by the method set out in the bylaws.

This corporation shall have two directors initially. The number of directors may be either increased or diminished from time to time by the bylaws but shall never be less than one. The name and address of the initial directors of this corporation is:

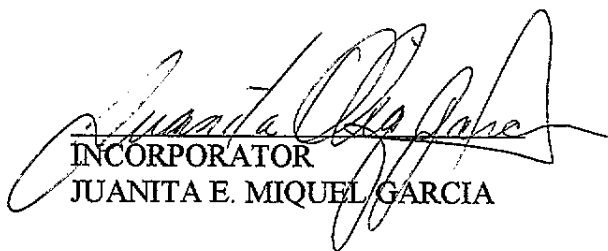
