

ARTICLES OF INCORPORATION  
OF

DREAMSCAPES IRRIGATION, INC  
A FLORIDA CORPORATION

THE UNDERSIGNED SUBSCRIBER TO THESE ARTICLES OF INCORPORATION, HEREBY FORM A CORPORATION UNDER THE LAWS OF THE STATE OF FLORIDA.

ARTICLE ONE- CORPORATE NAME

THE NAME OF THE CORPORATION IS: DREAMSCAPES IRRIGATION, INC.

ARTICLE TWO- DURATION

THIS CORPORATION SHALL EXIST PERPETUALLY UNLESS DISSOLVED UNDER FLORIDA LAW.

ARTICLE THREE- PURPOSE
