# ARTICLES OF INCORPORATION OF DYNASTY MERCHANDISING, INC.

The undersigned, acting as incorporator of **DYNASTY MERCHANDISING, INC.** under the Florida Business Corporation Act, adopts the following articles of incorporation.

### **ARTICLE I - NAME**
