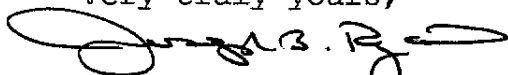

Name**

The name of the corporation is KOMAK CORPORATION.

**ARTICLE II

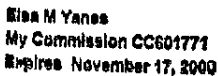
