**ARTICLES OF INCORPORATION**

**ARTICLE I: CORPORATE NAME**

The name of this corporation is **Renaissance Video Productions, Inc.**

**ARTICLE II: NATURE OF BUSINESS AND POWERS**

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

**ARTICLE III: CAPITAL STOCK**

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 10,000 shares of common stock having a par value of One Dollar (\$1.00).

**ARTICLE IV: TERM OF EXISTENCE**

This Corporation shall have perpetual existence, commencing upon filing of these Articles.

**ARTICLE V: REGISTERED AGENT AND INITIAL REGISTERED OFFICE**

The Registered Agent and the street address of the initial Registered Office of this Corporation in the State of Florida shall be: Mark Cotignola, 4733 Swindell Road, Lakeland, Florida 33810. The Board of Directors from time to time may move the Registered Office to any other address in the State of Florida.

**ARTICLE VI: BOARD OF DIRECTORS**

This Corporation shall have two directors initially. The number of directors may be increased or diminished from time to time by Bylaws adopted by the stockholders, but




