OF
SURGICAL INSTITUTE MEDICAL EQUITY CORPORATION**

ARTICLE I - NAME

The name of this corporation is Surgical Institute Medical Equity Corporation (the "Corporation").

ARTICLE X - INITIAL BOARD OF DIRECTORS


