ARTICLES I. NAME

The name of the corporation shall be:

BOOKER ENTERPRISES, INC.

The principal place of business of the corporation shall be 25525 S.W. 64th Place, Newberry, Florida 32669.

The mailing address of the corporation shall be 25525 S.W. 64th Place, Newberry, Florida 32669.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawfull activities or business permitted under the laws of the United States, the State of Florida or any other state, country or nation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1000 shares of common stock having \$1.00 par value per share.

ARTICLE IV. ADDRESS

ARTICLE V. BOARD OF DIRECTORS
