The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

#### ARTICLE I NAME

The name of the corporation shall be Randall Construction GROUP, INC.

#### ARTICLE II PRINCIPAL OFFICE
