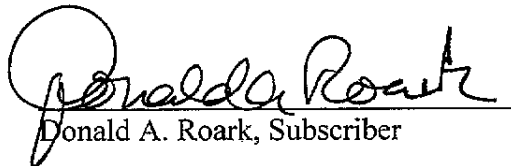
ARTICLE NINE - BY-LAWS

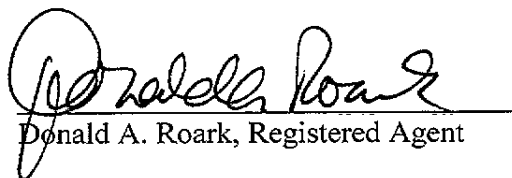
