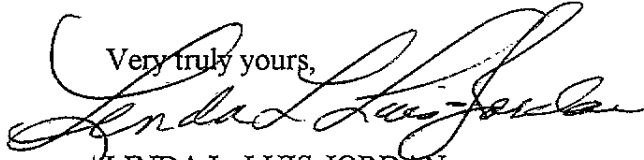

ARTICLES OF INCORPORATION
OF
LINDA'S NEST ENTERPRISES, INC.

I, the undersigned, do hereby associate for the purpose of becoming a corporation under the laws of the State of Florida, and do hereby adopt the following Articles of Incorporation.

ARTICLE I

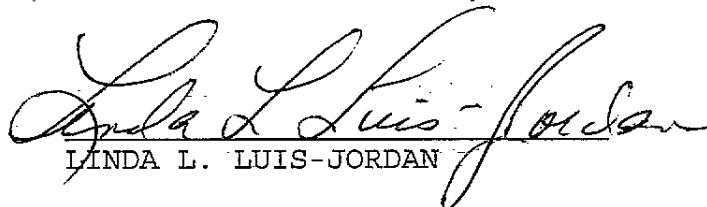

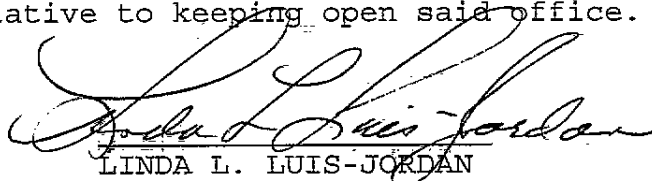
