The original of this AFFIDAVIT OF CONVERSION [Pursuant to 618.221, Florida Statutes] shall be filed with the Florida Department of State Division of Corporation and a duplicate thereof will be appended to the Minutes of the Annual Joint Meeting of Shareholders and Directors of Growers Precooler, Inc.
- 3. The corporation, by filing Articles of Incorporation of Growers Precooler, Inc., shall adequately protect and preserve the relative rights of the shareholders of the association so converting into a corporation for profit; provided that no rights or obligations due any shareholder of the corporation or any other person, firm, or corporation which has not been waived or satisfied shall be impaired by such conversion into a corporation for profit as authorized by Chapter 607, Florida Statutes.

ARTICLES OF INCORPORATION OF GROWERS PRECOOLER, INC.

The undersigned, acting as the Incorporator of a corporation for profit under the Chapter 607 Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation, converting same from a corporation organized under Chapter 618 Florida Statutes as provided in §618.221 Florida Statutes:

ARTICLE I

The name of this corporation is GROWERS PRECOOLER, INC.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose is to engage in any activities or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV

The corporation is authorized to issue 2,000 shares, all of one class, at \$100.00 par value.

ARTICLE V

The name and address of the Registered Agent is RAYMOND A. McLEOD whose mailing address is 48 East Main Street, Apopka, Florida 32703 and the principal office of this corporation is 2880 Lust Road, Apopka, Florida 32712.

ARTICLE VI

This corporation shall have one (1) Director initially, and the number of Directors may be either increased or decreased from time to time by an amendment of the By-Laws of the corporation in the manner provided by law, but shall never be less than one (1).

If all Director(s) severally or collectively consent in writing to any action taken or to be taken by the corporation, and the writings evidencing their consent are filed with the Secretary of the corporation, the action shall be as valid as though it had been authorized at a meeting of the Board of Directors.

ARTICLE XII

The existence of this corporation shall relate back to the 19th day of November, 1965.
