
To Whom it May Concern:

We recently became aware that the corporation was administratively dissolved by the State. List Realty, Inc. The taxpayer originally timely filed the 2001 UBR for the above referenced taxpayer timely. The report was returned to the taxpayer on May 9, 2001 along with a check for \$150. The check never cleared their bank account and because the State administratively dissolved the corporation, we can only conclude that you never received the report and check.

Once again, we are enclosing a check for \$150 and asking that the corporation be immediately reinstated. Furthermore, we request that the penalties related to reinstating this corporation be waived for just cause. We believe that the facts in this case support just cause to waive the penalties.
