OF

THE UNDERSIGNED, being the subscriber to the Articles of Incorporation of this corporation, formerly known as RICKEN, INC., which articles were filed on August 7, 1998, and which were amended to SUMMIT TITLE SERVICES, INC., on October 8, 1998, with the Secretary of the State of Florida, and further being all of the shareholders of the corporation, hereby amend the following articles to read as follows:

ARTICLE I

The name of the corporation is EPIC TITLE SERVICES, INC.

All other articles and provisions of the charter originally filed shall remain in full force and effect without modification.

This Amendment is adopted with the consent of all of the incorporators, directors, and shareholders of the corporation on this day pursuant to a joint meeting of the directors and shareholders of the corporation, all of whom have waived notice of said meeting, and who were duly present and voting.
