## ARTICLES OF INCORPORATION OF

The undersigned incorporator to these Articles of Incorporation hereby forms a corporation under the laws of the State of Florida as follows:

#### ARTICLE I

#### Name and Address

The name of this Corporation is INTELLIGENT SYSTEMS SOLUTIONS & SERVICES, INC. The mailing and street address of the Corporation is 7309 1<sup>st</sup> Avenue South, St. Petersburg, Florida 33707.

#### ARTICLE II

#### Term of Existence

This Corporation shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State.

### ARTICLE III

#### Purpose

This Corporation is organized for the purpose of transacting any and all lawful business.

#### ARTICLE IV Powers

The Corporation shall have the power:

(a) To have perpetual succession by its corporate name.

(b) To sue and be sued, complain and defend in its corporate name in all actions or proceedings.

(c) To have a corporate seal, which may be altered at pleasure, and to use the same by causing it or a facsimile thereof to be impressed, affixed or in any other manner reproduced.
