

The undersigned incorporators hereby certify to the following in order to form a corporation for a profit under the laws of the State of Florida.

# <u>ARTICLE I - NAME</u>

The name of this corporation is STRING APPRAISAL SERVICES, INC.

# <u>ARTICLE II - DURATION</u>

This corporation shall have perpetual existence.

#### ARTICLE III - PURPOSE

The general purposes for which the Corporation is organized are the following:
