In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is FASTMATCH REALTY, INC.

ARTICLE II

The existence of the corporation shall begin on the day of filing the articles of incorporation.

ARTICLE III

The street address of the principal office of the Corporation is 1838 Ivanhoe Rd, Orlando, Florida, 32804.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 100,000, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote. The par value of such shares shall be \$.10 per share.

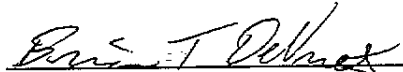
The corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.
