the Florida Business Corporation act, does hereby adopt the following**

**Articles of Incorporation**

**ARTICLE I**

**NAME**

**The name of the Corporation shall be: Community Utilities II, Inc.**

**ARTICLE II**

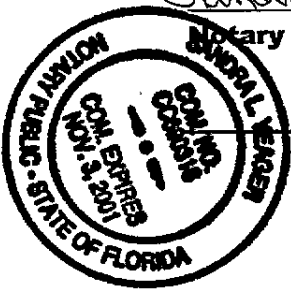
