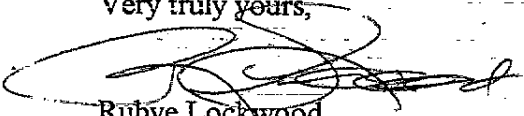

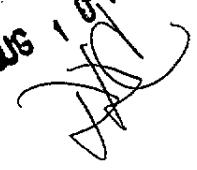

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

WALLACE'S BOOK STORE (CFCC), INC.

ARTICLE II. NATURE OF BUSINESS

ARTICLE VI. INDEMNIFICATION

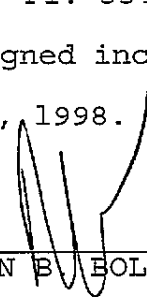
The corporation may indemnify any officer, director, employee, or agent or any officer, director, employee, or agent to the extent permitted by law.
