ARTICLES OF INCORPORATION

OF

B & E, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is B & E, INC. whose principal place of business is: 4747 Nob Hill Road, Suite 16, Sunrise, Florida 33351.
