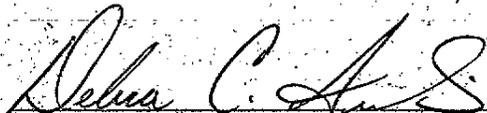

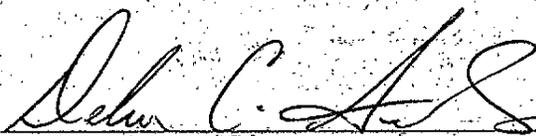
CERTIFICATE OF DESIGNATION OF
