#### **ARTICLE I**

The name of the corporation shall be: AUTOMATIC DOORS, INC.

#### **ARTICLE II**

The corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation by and with the Department of State.

#### **ARTICLE III**
