

ARTICLES OF INCORPORATION OF PSI #37, INC.

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is PSI #37, INC. and its principal office and mailing address is 2000 N. Florida Mango Road, Suite 200, West Palm Beach, FL 33409.

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence on the date of subscription and acknowledgment of the Articles of Incorporation.
