I. CORPORATE NAME

The name of this corporation is:

III. NATURE OF BUSINESS AND POWERS.

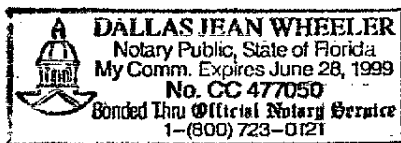
to vote, unless all of the directors and all of the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.
