

Articles Of Incorporation Of Shreeji America, Inc. (A Florida Corporation)

Article I NAME The name of this Corporation is Shreeji America, Inc.. Article II PURPOSE This Corporation is organized for the purpose of any and all lawful business in the State of Florida. Article III DURATION This Corporation shall have perpetual existence.
