# ARTICLES OF INCORPORATION

### OF T.H. GROUP, INC.

### ARTICLE I. CORPORATE NAME

The name of this corporation is: T.H. GROUP, INC., where the principal office is: 15216. Amberly Drive, #2115, Tampa, FL 33647.

### ARTICLE II. NATURE OF BUSINESS AND POWERS.

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

#### ARTICLE III. CAPITAL STOCK.

The aggregate number of shares which this corporation shall have authority to issue is 1,000.00, shares of common stock having a NON Par value per share.

### ARTICLE IV. TERM OF EXISTENCE.

This Corporation shall have perpetual existence commencing upon approval of the State.

This Corporation shall have ONE Director(s) initially. The number of Directors may be increased or diminished time to time by Bylaws adopted by the stockholders, but shall never be less than one.
