The name of the corporation, which was organized under Chapter 607 of the Florida Statutes, is "Art Network of America, Inc. (the Corporation).

The amendment adopted is to amend the corporation's authorized Capital Stock set forth in Article V of the Articles of Incorporation, which amendment shall be effective as of the filing of these Articles of Amendment, so that, as amended, said Article V shall read as follows:

# ARTICLE V CAPITAL STOCK

The aggregate amount of total authorized capital stock this corporation proposes to issue without further notice is:

The aggregate authorized capital stock of this corporation is One Million (1,000,000) shares of common stock with a par value of \$0.01 each, all of which are of the same class; and One Hundred Thousand (100,000) shares of preferred stock with par value of \$1.00 each, all of the same class. The aggregate par value of all shares is Ten Thousand Dollars (\$110,000).
